## Guidelines

All works of art must be original and solely attributed to the artist whose name is on the application. Literal copies of photographic sources are not accepted. Photo reproductions are not considered original works of art and may not be exhibited, they may however be placed in a bin for display. All art kits, ceramic casts from commercial molds, or commercial displays are not permitted. Cobb County neither carries liability insurance nor accepts responsibility for artwork. The artist agrees to release the county and its employees from all liability. The Art Place staff assures the artist that every care will be taken to protect their work.

The Art Place retains 30% of any sales made in the gallery. Each artist receives the remaining 70% by check from Cobb County within 30 days of the closing of the exhibit. All artists must complete a Cobb County Vendor Application and W-9 form to be paid for sold inventory. Please ask for these forms upon delivery of work and inventory list (s).

The artist must deliver, pick-up and re-pack artwork for exhibit. The Art Place staff will hang artwork with extreme care but cannot be held responsible for breakage. Specific instructions for hanging should be written/ drawn out on paper for TAP Staff before the show is hung. TAP retains the final word on the placement of work. Works exhibited must be consistent in style and quality to those viewed by the jurors. *The Art Place Staff may remove any exhibitor whose work widely differs from their submissions or is not ready for hanging or display.* All work must remain on display for the entire time span stated on the contract. Art work not picked up after closing date is no longer under protection of the gallery. Artwork left over 6 weeks without any correspondence becomes the property of TAP.

## Process

Three jurors will receive and select our gallery schedule of shows for the 2018 calendar year. They have full freedom to arrange the combinations of artists that will make-up each show. After this selection process, we will notify each artist as to whether or not they were selected and the dates of the show they were selected for. Contracts will be sent out at that time and the return of that contract will seal the show. Any changes, adjustments to dates etc., must be made prior to signing the contract. In the case of a pull-out, the artist must notify The Art Place 6 months in advance to allow for staff to find another appropriate artist for that particular show.

## Emailed Images, Disc or Actual Art

Must be marked with artist's name, title, media, size, and price. Only quality images and complete information will be accepted. J-peg files 300 dpi are the most successful for us to receive. You may send work on a CD/disc. If you wish it returned please send a self-addressed stamped envelope with your application. Accepted artwork will be retained until their exhibit and all unaccepted images will be returned. All artwork without a price listed will be entered as Not for Sale. Email images to:
